

2020 NDAA included:

- 3.1% pay raise
- TRS for mil techs (starting in 2030)[* next slide]
- 12304b early retirement credit retro to 2012
- GI Bill transferability with no max years of service
- Military student identifier for RC children
- Repeal SBP/DIC offset by 2023
- Paid family leave for federal employees
- Establish US Space Force with JCS seat
- Single standard record of service (DD 214) to include Guard and Reserve service
- No involuntary ANG mil tech conversions to AGR
- No subjective upgrade on USR
- Report on incentives (bonus, SLRP) for AGR/Mil Tech
- Report on paying BAH vs OHA in territories
- Plan on phase out of burn pit usage

*TRS for Mil Techs in 2030 explained:

- Congressional Budget Office (CBO) determines the cost of each bill over a 10-year period
- © CBO computed this provision would cost about <u>\$200 million</u> in <u>mandatory</u> spending (such as Social Security, Medicare, VA pensions); but would save the government about <u>\$1.5 billion</u> in <u>discretionary</u> spending (such as DOD funding)
- Armed Services Committees had to find an offset to \$200 million in mandatory spending and did not, so they set the effective date 10 years out, in 2030
- We will work with Congress to help find an offset that will bring effective date closer to current date.
- At least the repeal of the restriction is in law!

SUBJECT: National Guard Members Supporting the Southwest Border Security Mission in a Title 32 Status

I have determined that members of the National Guard who perform active service under title 32, U.S.C., section 502(f), at the request of the Secretary of Defense in support of Department of Homeland Security activities to secure the southern border of the United States are "responding to a national emergency declared by the President and supported by Federal funds" for purposes of determining eligibility for Post-9/11 GI Bill educational benefits and other specified benefits, as applicable, effective February 15, 2019, the date of Presidential Proclamation 9844, "Declaring a National Emergency Concerning the Southern Border of the United States." The Under Secretary of Defense for Personnel and Readiness (USD(P&R)) is directed to provide an analysis of any other benefits or entitlements resulting from my determination, as well as any implementation guidance, as necessary.

The Secretary of the Army and the Secretary of the Air Force will take necessary actions to ensure that members of the National Guard affected by this determination have a record of their eligibility for any associated entitlements or benefits, consistent with any implementation guidance issued by the USD(P&R).

By the authority vested in me as President by the Constitution and the laws of the United States of America, including the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207 (the "Stafford Act"), and section 502 of title 32, United States Code, it is hereby ordered as follows:


