Past President Message:

Greetings Association members,

During a retirement party for one of our members I had a conversation with a retired NCO who was not familiar with the process of when they could apply for retirement pay. I found this information on Military .com. Please share with your Soldiers and Airmen that are nearing retirement.

Military Guard or reserve retirement can be an important part of a retirement funding plan, and reaching your 60th birthday and becoming eligible to receive your Guard or reserve retirement is a big deal. If you're in this situation, congratulations, and thank you for your service!

It is important to know that Guard or reserve retirement pay doesn't start coming automatically; you have to apply for it. Applications for Guard or reserve retirement pay are sent to eligible members prior to their 60th birthday, at the address that the service has on file for the retiree. It is super-important that you ensure that the appropriate Reserve Personnel Command or State Headquarters has all your correct contact information at all times so that you don't get "lost in the cracks" when it comes to your retirement.

Reserve component members generally receive a retirement pay application via the regular mail during the year in which they are 58 years old. Guard members generally receive a retirement pay application via the regular mail approximately six months prior to their 60th birthday. If you don't receive your retirement pay application, please reach out to your Reserve Personnel Command or State Headquarters to see what has happened to your application!

Retirement pay applications must be completed and returned to the appropriate offices in order for retirement pay to start in a timely manner. For most retirees, that is the month following the month in which they turn 60.

The date of eligibility to begin receiving a Guard or reserve retirement is slightly different for certain reservists who served on extended active duty under certain conditions. For service after 28 January 2008, the age at which a retiree can draw retiree pay is reduced by three months for each aggregate 90 days of active duty service during any fiscal year. Effective 30 September 2014, that benefit is modified slightly to group the 90 days periods within two fiscal years. This calculation is a little tricky, but the Army's Human Resources Command has a super-thorough fact sheet with a calculator. Read through this page carefully if you think you qualify for reserve retirement pay prior to age 60. The earliest a reserve or Guard component member can begin receiving retirement pay is aged 50, regardless of the amount of eligible active duty time served.

Eligible Guard or reserve retirees who do not apply for their retirement pay when they turn 60 are eligible for full retro-active pay as long as the payments begin by the time they turn 66. After age 66, a penalty is applied to the payments. You definitely don't want to be penalized and lose any of those benefits that you have earned.

Senior NCOs who are requesting assistance for their service member (SM) should review the instructions on the application. Requests need to come from the 1SG/NCOIC w/ an endorsement of CSM/CMSgt or, the FAS, if others are deployed.

Follow the instructions on the form completely
The SMA does not <u>normally</u> pay funds to the
SM. We do send the funds to the SM but the
check is made out to the party owed. The SM is
responsible to arrange for debt payment.
These funds are a grant and there is no repayment expected. However, SM who are able to
help support the Chaplain's Fund are free to
help other SM in need. An updated fillable pdf
form will be included in distribution of each
newsletter.

The Sergeants Major Association of California, Inc was chartered in the State of California on 19 October 1968 as a social, patriotic organization advocating the following creed: "We, the Members of the Sergeants Major Association of California, being desirous of improving the status and image of the National Guard and promoting the wellbeing, welfare and qualifications of the Enlisted members of the National Guard, dedicate ourselves to maintaining the professionalism required of us. and pledge ourselves to this creed." The Association was founded by a group of Sergeants Major from units throughout California. The goals of the Association since its inception, has been to enhance the image of the National Guard and provide a means of communication for Senior Noncommissioned Officers. Membership is open to all Active, Retired, or Honorably Discharged Senior NCOs (E-7 through E-9) of the National Guard, California State Guard, and Reserve Components. An Associate Membership is available for Family Members, Businesses, and Concerned Citizens who share our common goals. In the early years, the Association's focus was on supporting the Soldier and NCO education systems at Camp San Luis Obispo and Camp Roberts. Currently we are actively working with CSLO to modernize Parker Hall so that it will again be a relaxing place for both Soldiers and NCOs to socialize. We also support the Army and Air Service Members of the Year program, CAL GUARD Ready Families programs and we manage the Sergeants Major Association Chaplains Fund, which aids California National Guard Servicemembers throughout the State. We continually look for new ways to respond to the everchanging requirements of the National Guard to better support both Senior NCOs and Junior Enlisted Soldiers. Dues in the Association are \$40.00 per year, with an additional \$15.00 initiation fee for new members for the first year of membership.
