Why They Exist

- The Anti-lobbying Act (18 USC 1913) prohibits expenditure of Federal funds on grassroots lobbying efforts to include public contact with Congress concerning legislation or appropriations. Fiscal Law dictates the same.
- As an advocacy organization, EANGUS is able to discuss issues that affect the National Guard and are not obligated to support the President's Budget Proposal or Administration priorities like NGB must.
- ☐ State Associations also represent their members and initiate or support legislation to provide additional "State Benefits".

- ☐ The We Care for America Foundation, Inc. (WCFA) is the 501c(3) charitable arm of EANGUS. The WCFA National Guard Emergency Relief Fund currently provides THREE types of emergency assistance:
 - Individual SARGE grants (usually \$500)
 - Disaster relief (for major declared emergencies)
 - No-interest loans up to \$2,000



- □ Since 2004, WCFA has provided almost \$2M to NG members, which includes almost \$1M in grants given to NG members impacted by the COVID 19 pandemic over the last two years. These grants and the establishment of our No-Interest Loan program were made possible by significant donations from USAA and the USAA Foundation.
