Preparing for the Future



Update AB46, Exemption of Military Retirement Pay

Plans to reintroduce legislation exempting some or all uniformed services retirement pay and survivor benefits from state taxes are in place in two states where summer deadlines passed without bills reaching the governor's desk. Here's a look at the latest from California and Delaware, plus some details on other states where work on an exemption will continue, thanks in part to efforts from MOAA members and affiliates.

AB 46, a state assembly bill which would have exempted all uniformed services retirement pay and survivor benefits from state taxation, will not become law this session despite clearing several legislative hurdles and never receiving a "nay" vote since its May 2023 introduction.

This California Assembly passed the bill by a 77-0 margin that month, then two Senate committees unanimously moved it forward before it was placed in the state's "suspense file," where the Senate Appropriations committee sends legislation costing more than \$150,000 for further consideration (without further testimony). The bill was held over by the committee in 2023 but was not moved forward by the committee in its Aug. 15 session.

The bill was supported not only by the California Council of Chapters of MOAA (CALMOAA), but also by state-level affiliates of the American Legion and the Marine Corps League, as well as the <u>California State Veterans Commanders Council</u> and nonmilitary advocacy groups.

Efforts to secure the support of Gov. Gavin Newsom have been unsuccessful; Lt. Cmdr. Jeff Breiten, USN (Ret), CALMOAA vice president of legislative affairs, said the governor "has sat silently on the sidelines failing to support any legislation that was introduced each of those five years that would have provided an exemption on military retirement pay."

Breiten, citing DoD's Office of the Actuary, said California's military retiree population declined for the 11th straight year in 2023.

Legislators have expressed interest in introducing a bill for the 2025 session, Breiten told MOAA. Talks will continue with lawmakers as advocates work to craft a bill that will carry the governor's support.

Delaware

Legislation that would have partially exempted uniformed service retirement pay and survivor benefits from state taxes did not advance out of committee in the Senate before the June 30 end of the state legislative session.

SB 201 would have increased existing maximum exemptions to \$15,000 for the 2024 tax year, \$20,000 in 2025, and \$25,000 in 2026 and thereafter. The bill was amended to include Coast Guard, U.S. Public Health Service, and NOAA members.

MOAA's Dover Chapter "will continue to 'drive on to the Ranger objective'" with the tax legislation next session, said Col. Eugenia "Gene" Thornton, USA (Ret), Dover Chapter president.

Thornton highlighted the chapter's support of other pro-veteran legislation that did become law, to include bills updated state laws to include Space Force members; offer children of servicemembers priority in school enrollment; reduce wait times for interment at state veterans cemeteries; and allow the state to accept "concurrent jurisdiction over juvenile matters on military installations," which could allow some juvenile cases to be resolved in the state's Family Court instead of federal courts.

The National Guard Relief Foundation may be able to help with an interest-free loan or grant. Grants are generally no more than \$500, and interest-free loans are available in amounts from \$500 to \$2,000. Low monthly repayment terms are established based on the loan amount.

EANGUS 2024 Legislative Priorities: A Focus on Reproductive Healthcare, Deported Veterans, and Veterans Court Services

As the Enlisted Association of the National Guard of the United States (EANGUS) outlines its legislative priorities for 2024, the organization has underscored its commitment to advancing key issues that directly impact the lives of National Guard members and veterans. Among the top priorities are three critical initiatives championed by the California Enlisted Association of the National Guard of the U.S. (CAL EANGUS): the expansion of access to in vitro fertilization (IVF) and reproductive healthcare, the expedited return of deported veterans to the United States, and the expansion of Veterans Court Services programs. These initiatives reflect EANGUS's dedication to addressing the evolving needs of its members and the broader veteran community.

Expansion of Access to IVF and Reproductive Healthcare

One of the primary legislative priorities for EANGUS in 2024 is advocating for the expansion of access to in vitro fertilization (IVF) and comprehensive reproductive healthcare services for National Guard members and their families. The rising costs and limited availability of these services have made it increasingly difficult for many service members to start or expand their families. EANGUS is pushing for legislation that would ensure all National Guard members have access to affordable and timely reproductive healthcare, including IVF, regardless of their duty status.

This initiative recognizes the unique challenges faced by National Guard members, who often juggle civilian careers with their military duties. Access to reproductive healthcare is not just a matter of medical necessity but also one of equity and support for those who serve. By expanding access to these services, EANGUS aims to alleviate the financial and emotional burdens associated with infertility and reproductive health challenges, ensuring that service members and their families receive the care they deserve.

Expedited Return of Deported Veterans

Another key priority for EANGUS in 2024 is advocating for the expedited return of deported veterans to the United States. Despite their service to the nation, many veterans have faced deportation due to legal and immigration issues. EANGUS is calling for legislation that would facilitate the prompt return of these veterans, recognizing their contributions and ensuring that they are treated with the dignity and respect they have earned through their service. This initiative is particularly important to CAL EANGUS, which has been at the forefront of efforts to support deported veterans. The organization argues that veterans who have served honorably should not be subject to deportation and should be provided with a pathway to citizenship. By prioritizing the return of these veterans, EANGUS aims to correct past injustices and provide these individuals with the opportunity to reintegrate into American society, where they can access the benefits and services they earned through their military service.

Veterans Court Services Expansion Program

EANGUS is also championing the expansion of Veterans Court Services programs across the United States as a legislative priority in 2024. Veterans Courts are specialized court programs that focus on rehabilitation and support for veterans who find themselves in the criminal justice system, often due to issues related to PTSD, substance abuse, or other service-connected conditions. The expansion of these programs is particularly relevant in California, where the veteran population is among the largest in the country. EANGUS is advocating for increased funding and resources to establish more Veterans Courts, ensuring that veterans receive the care and support they need to address the underlying causes of their legal issues. By expanding these services, EANGUS aims to reduce recidivism rates among veterans, improve their overall well-being, and help them successfully reintegrate into civilian life.

The 2024 legislative priorities for EANGUS reflect the organization's unwavering commitment to supporting National Guard members and veterans. By focusing on the expansion of reproductive healthcare, the expedited return of deported veterans, and the growth of Veterans Court Services programs, EANGUS is addressing some of the most pressing issues facing the military and veteran communities today.

These priorities, with strong backing from California, highlight the importance of comprehensive support systems for those who have served. EANGUS's advocacy efforts in these areas will be crucial in shaping policies that enhance the quality of life for National Guard members and veterans across the country.
